AAP's manufacturing plant is located at 2376 Main Street, Billings, Montana USA with warehouses and offices at the same location.
- **Non-Irradiation Statement:** The electronic beams, radioactive rays, and other radiation have never been utilized for sterilization on our product.
- **Non-GMO-Statement:** Kre-Alkalyn® is subjected to extensive testing to ensure that the product is completely free of any Genetically Modified Organisms (GMO) and is not sourced from any GMO materials.
